We are pleased to announce an exciting, new partnership between the United States Senate Youth Alumni Association and the Partnership for Public Service to promote government service by USSYAA alumni.

The Partnership for Public Service is a non-partisan, nonprofit organization dedicated to meeting the needs of government by inspiring a new generation to serve and transforming the way government works. The organization works with other groups and national leaders that believe a strong civil service is vitally important to the country. These partners include many members of the business community, hundreds of colleges and universities, other non-profit organizations, and government leaders. Among the esteemed members of the Partnership's Advisory Board is The Hon. Susan Collins, the United States Senator from Maine and, as you know, an alumna of the United States Senate Youth Program.

The Partnership has a number of programs and initiatives. It works directly with agencies to transform the government as a workplace. It supports legislative reform to remove outdated laws that discourage government service by the best and the brightest. It conducts research and policy analysis on challenges facing the federal workforce. And it offers education and outreach programs to persons of all ages interested in government service.

The Partnership's education and outreach programs attracted the interest of the USSYAA Board. In particular, the Partnership has collected information about and electronic links to a number of internship and fellowship programs in government service as well as opportunities for permanent employment with the federal government at their website www.calltoserve.org. Alumni may have particular interest in exploring federal executive branch internships, State Department internships, federal career-path internships, Smithsonian internships, the Presidential Management Fellows Program, the White House Internship Program, and many more. The Partnership even has its own program, the Partnership Fellows Program, which accepts applications from college students and graduates who share a commitment to public service and a desire to help revitalize the federal government.

Alumni who are currently in federal service may want to consider joining the Partnership's Speakers Bureau which links dynamic federal employees with organizations—often colleges and universities—that are looking for speakers on government service. Another program of interest to federal employees is the Partnership's Service to America Medals program that honors civil servants who have made important contributions to the country. Nominations are accepted each year during the winter months, and we hope the USSYAA community will help the Partnership honor unsung heroes in federal service by nominating deserving federal employees.

We invite you to review the vast information on the Partnership for Public Service website www.ourpublicservice.org and to pursue the many opportunities that you will there find. Our two organizations share a commitment to promoting the cause of good government, and USSYAA is committed to facilitating the career development of its members. Please do not hesitate to contact us if you see other opportunities for collaboration between our organizations. We look forward to sharing additional information about our partnership in the months ahead. We believe that this partnership between the Partnership for Public Service and the USSYAA will help accomplish both goals!

Frehse and Almon Receive 2004 Alumni Service Awards

For the past five years, USSYAA has presented an annual service award to individuals who have made significant contributions to the U.S. Senate Youth Program or the Alumni Association. On February 28, 2004, USSYAA President Robert Middleton (DC 1966) presented the award to Robert M. Frehse, Jr., Executive Director of the William Randolph Hearst Foundations, and Rita Almon, Program Director of the United States Senate Youth Program of the William Randolph Hearst Foundations. Middleton recognized both individuals for their many years of service and dedication to the United States Senate Youth Program. The presentation took place at the Mayflower Hotel before foundation officials, program alumni, and military escorts. The award consists of an engraved plaque, which bears a color likeness of the United States flag.

Prior to joining the Hearst Foundations, Frehse spent more than 20 years with Citibank in its overseas divisions. Frehse currently serves as a director of the Council of Independent Colleges and as a Trustee and member of the Executive

Committee of the Interchurch Center. He is a member of the Board of Visitors of Wake Forest University and a Fellow of The Foreign Policy Association of New York. Almon's previous positions were with the University of California at Los Angeles, the Haversham Art Gallery of London, and Stanford University School of Law. Almon serves as a volunteer officer and board member of the National Center for Equine Facilitated Therapy.

Mr. Hulvey passed away on Thursday, August 6, 2004, in Loma Linda, California, of heart failure. Mr. Hulvey's services were held in Palm Springs on August 21.

Mrs. Hundley passed away on Saturday, August 21, 2004, in Hemet, California, after undergoing a significant surgical procedure. A memorial service was held on Saturday, August 28, 2004 in Hemet, California.

Craig served as the USSYAA's Parliamentarian until 2004. Gladys continued working on USSYAA business until her death, and was always a witty, outgoing participant in all of our board meetings. Her participation and guidance will be sorely missed.

Nero Selected for Alumni Scholarship

Members of the alumni scholarship committee have carefully considered the applicants' documents and have selected **Leah J. Nero (VT 1998)** as the recipient of the 2004 Rosalie Wynn and George Randolph Hearst, Sr., Alumni Scholarship.

Ms. Nero is a political science/Spanish graduate of Union College at Schenectady, New York. She is currently completing pre-requisite course work at Salem State College in Salem, Massachusetts.

At Boston Medical Center, Boston's only public hospital, Ms. Nero worked on a NIH-funded clinical study examining HIV disease progression.

Ms. Nero's personal statement included with her application refers to beginning full time Master's FNP (Family Nurse Practitioner) study at Yale University School of Nursing. To quote Ms. Nero: “By becoming a Family Nurse Practitioner and addressing clinical issues for underserved populations, I will provide critical service for community health needs in a manner that values understanding families within their distinct contexts.”

"I appreciate that NPs are empowered with an extensive educational background to complement physician care while operating under a separate license. Unlike the strictly medical model's focus on *curing*, nursing distinctly suits me by offering service and scholarship while privileging the pursuit of *caring*." Ms. Nero is dedicated to providing equal access to health care for children and adults. She is eager to serve in a community health center in an underserved area in rural Vermont.

Our committee believes Ms. Nero embodies the vision Mom Hearst created for us and we are proud to recognize this alum's achievements and commitments.
